## School Uniform Policy

The School policy towards the wearing of uniform allows our children to demonstrate their, and their families or carers, respect for our School, as well as help eliminate problems caused by bullying around fashion, money and taste.

The policy helps our children view their School as a community of equals.
We believe that pupils learn most effectively and achieve their best outcomes when they are comfortable, able to be themselves, and dressed in such a way that sets an appropriate tone for education.

In order to keep costs as low as we can, we have one 'official' supplier but known supermarkets also sell our jade coloured jumpers / cardigans. Information about this can be found on our website.

You are welcome to select unbadged clothing, albeit in the School Colours, if you so wish from alternative sources.
We have a limited supply of used uniform items, all of which are in good condition to support children and families in need. All enquiries need to be submitted to the School Office where they will be passed to a designated staff member, all enquiries are confidential.

Mobile devices are not to be carried by pupils and similarly other communication devices (such as smart watches with WiFi or cellular connectivity) should not be worn.

## Foundation Stage

In Reception children wear a white polo shirt, with grey skirt, pinafore, shorts or trousers. A jade green sweater, sweatshirt or cardigan is also worn. It is a great assistance if this can be labelled; many parents choose to have their child's initials on the front of their clothing. A PE kit is not needed.

Our Nursery aged children may also wear our uniform if parents wish.
Plain, dark, shoes or trainers are worn by all the children, Velcro is great choice of fastener as it allows the younger children more independence. Shoes with a pronounced heel must not be worn.

## Key Stage 1 and 2

Our colours in Key Stage 1 and 2 are jade green tops (sweatshirts, cardigans or sweaters) and white shirts or polo shirts, with grey trousers, shorts, skirts or pinafore dresses. Green check dresses may be worn in summer although parents should remember these may not be suitable for all activities. Plain, dark, shoes or trainers are worn by all the children, Velcro is great choice of fastener as it allows the younger children more independence. Fashion shoes such as open toed sandals, sliders, jellies or shoes with a pronounced heel must not be worn. School fleeces and waterproof jackets are available.

## All Year Groups

All children, from Foundation Stage through to Year 6 are expected to comply with these rules.
Religious or faith-based clothing is perfectly acceptable, following the spirit of the guidance in this document.
Jewellery or items of sentimental value should not be worn.
Smart watches, like mobile phones are not permitted and should be handed in to staff, at the start of the day. A watch may be worn, that can be reasonably judged by the Head teacher as appropriate for working and playing at school; it is recommended that this be of a low value.

All uniform may be ordered directly with suppliers or purchased from local retail shops.
A Uniform display is available to view in school to help you understand the choices available.
A supply of used, but still in very good condition items, is maintained by school. Items have been cleaned/ washed before they are made available. They are stored with care and are always available. These items are available in a range of sizes. They are available free of charge.

To keep costs as low as we can, we have a local supplier and well known supermarkets also stock our choice of jade green jumpers/cardigans. Please see our website for further details.

You are welcome to select unbadged clothing, albeit in the school colours, if you so wish

## What is not allowed at Overfields Primary School?

Sportswear, including football shirts as well as denims, jeans and fashion clothing and footwear are not allowed.

## Sports Kit

Your child must have a PE kit of black shorts, plain white T shirt (not a football shirt) and plimsolls or trainers, kept in a PE bag and in school on every day. An outdoor kit is also required during colder months; most parents add a sweatshirt and joggers, possibly some older trainers.

Children having swimming lessons will also need a swimming costume (not bikini) or swimming trunks (not Bermuda shorts) and a towel.

The wearing of all cosmetic jewellery is strongly discouraged, although older children may wear a watch. Arrangements should be made to remove earrings for PE lessons, we do not allow earrings to be covered with tape or a plaster for health \& safety reasons. We encourage pupils wanting to have their ears pierced to do this during the 6 week holiday so that it does not impact on their participation in physical activity.

## Hair styles

Long hair should be tied back, and the school discourages some specific hairstyles, for example shaved lines or coloured hair. Please discuss your proposed haircut with the Head Teacher before having it cut if in doubt! We also discourage the wearing of over-large fashion bows as they can restrict vision for other children when seated.

For safety reasons, acrylic or fake nails should not be worn. These can cause serious injuries if they are ripped off and may also hinder a pupil's ability to participate fully in lessons.

## Roles and responsibilities

The Trust have set the framework for this Policy.

## The governing board is responsible for:

- Establishing, in consultation with the headteacher and school community, a practical and smart school uniform that accurately reflects the school's vision and values.
- Ensuring that the school's uniform is accessible and inclusive, and does not disadvantage any pupil by virtue of their protected characteristics or socio-economic status.
- Ensuring a supply of used, but still in very good condition items, is maintained by school. Items have been cleaned/ washed before they are made available. They are stored with care and are always available. These items are available in a range of sizes. They are available free of charge.
- Listening to the opinions and wishes of parents, pupils and the wider school community regarding changes to the school's uniform.
- Ensuring that the school's uniform is accessible and affordable.
- Demonstrating how best value for money has been achieved in the uniform policy.
- Ensuring compliance with the DfE's 'Cost of school uniforms' guidance.
- Processing and approving all eligible School Uniform Assistance Application Forms.


## The headteacher is responsible for:

- Enforcing the school's uniform on a day-to-day basis.
- Ensuring that teachers understand this policy and what to do if a pupil is in breach of the policy.
- Listening to the opinions and wishes of the school community regarding the school's uniform and making appropriate recommendations to the governing board.
- Providing pupils with an exemption letter as appropriate, e.g. for a pupil who has a broken arm and requires a loose-fitting top.


## Staff members are responsible for:

- Ensuring that pupils dress in accordance with this policy at all times.
- Disciplining pupils who are in breach of this policy.
- Ensuring that pupils understand why having a consistent and practical school uniform is important, e.g. school identity.


## Parents are responsible for:

- Providing their children with the correct school uniform as detailed in this policy.
- Informing the headteacher if their child requires a more relaxed uniform policy for a period of time, including why.
- Ensuring that their child's uniform is clean, presentable and the correct size.


## Pupils are responsible for:

- Wearing the correct uniform at all times, unless the headteacher has granted an exemption.
- Looking after their uniform as appropriate.
- Understanding and respecting why a school uniform is important to the school, e.g. school identity and community.


## Cost principles

The school is committed to ensuring that its school uniform is affordable and accessible to all pupils, and does not place an unreasonable financial burden on parents.

In accordance with the 'School Admissions Code', the headteacher will ensure that the school's uniform policy does not discourage parents from applying for a place for their child.

The school will assess the overall cost implications of its uniform policy regularly, including prior to making any changes to the school uniform. When evaluating whether costs are reasonable and proportionate, the school will consider the opinions and situations of:

- Economically disadvantaged parents.
- $\quad$ Parents with multiple children who are, or will be in the future, pupils at the school.
- Parents of younger children, as they are likely to grow quickly and require new sets of uniform more frequently.
- Parents of pupils with protected characteristics that may impact their ability to access the uniform due to costs.
- LAC (Looked After Children) and PLAC.

School will evaluate the cost of its uniform based on the overall collection of uniform items that parents would need to purchase for a pupil, rather than on the cost effectiveness of individual items; this will include consideration of the fact that parents will need to purchase multiples of certain items, e.g. shirts and socks, to ensure their child can come to school in clean uniform every day.

School keeps variations in school uniform for different groups of pupils, e.g. year group-specific items or house colours, to a minimum where possible to ensure that pupils can get the most wear out of their uniform possible and that parents can pass some items down to younger siblings.

The school keeps branded uniform items to a minimal level that is reasonable for all members of the school community. The school defines a branded uniform item as any item of clothing that cannot be purchased at a range of retailers, including by virtue of logos, colours, design and fabrics. Where the school decides to require an item of branded clothing, it will conduct an assessment to ensure prices are kept as low as possible, e.g. by offering sew- or iron-on logo badges for jumpers that can be bought at retailers instead of requiring special branded jumpers, ensuring that at least two retailers are available. Colours must be widely available from several retailers.

The school is committed to meeting the DfE's recommendations on costs and value for money. Every care is taken to ensure that our uniforms are affordable for all current and prospective pupils, and that the best value for money is secured through reputable suppliers.

The school works with multiple suppliers to obtain the best value for money possible. Any savings negotiated are passed to parents where possible and does not enter exclusive single supplier contracts or cash-back arrangements.

The school will not amend uniform requirements regularly and will take the views of parents and pupils into account when considering any changes to school uniforms.

## Equality principles

The school takes its legal obligation to avoid discriminating against any protected characteristic unlawfully very seriously, and aims to ensure that the uniform policy is as inclusive as possible so that all pupils are supported to access a school uniform which is comfortable, suitable for their needs, and reflects who they are.

The school will work to ensure that school uniform's cost does not disproportionately affect any pupils by ensuring that uniforms for all genders are as equal in price as possible and by adhering to the cost principles laid out above.

The school will ensure that parents and pupils are consulted over any changes to school uniform, and that views and advice is sought specifically from pupils, and parents of pupils, who:

- Are transgender, including non-binary pupils.
- Have SEND (Special Educational Needs and Disabilities) and/or sensory needs.
- Are of a religious or cultural background that has dress requirements.

The school implements a gender-neutral uniform, meaning that pupils are not required to wear specific items based on their gender, and may wear any of the uniform items listed in the 'School uniform' section of this policy regardless of the legal sex recorded on the school's records. Transgender pupils are supported to access the uniform that best reflects their gender expression in line with the inclusive nature of our school.

The school ensures that pupils who are required to follow certain dress requirements, e.g. by virtue of their membership of a particular religious or cultural group, are afforded flexibility to allow them to wear a uniform that adheres to their requirements as far as possible. The school endeavours to meet all requests for amendments to the uniform for these purposes; however, will ensure that the needs and rights of individual pupils are weighed against any health and safety concerns for the entire school community.

Parents' concerns and requests regarding religious clothing are dealt with on a case-by-case basis by the headteacher and governing board, and always in accordance with the school's Complaints Procedures Policy.

The school ensures that the needs of pupils with SEND and/or sensory difficulties are considered in the uniform policy, e.g. ensuring soft, stretchy fabrics and avoiding intricate buttons or hard seams; however, where the needs of these pupils cannot be met in the standard uniform policy, individual adaptations to the uniform will be considered and permitted wherever possible.
